4.16.010.A.19.e-Public Nuisance- Visual Blight-Junk/refuse/garbage visible

It is unlawful and it shall be declared a public nuisance for any person owning, leasing, occupying or having charge or possession of any premises or property in the City to maintain any such premises or property or improvement thereon in such a manner as to cause or to allow the premises, property or improvement to become defective. unsightly, or in such other condition of deterioration or disrepair as the same may cause substantial depreciation of the property values or similar detriment to surrounding properties, as well as an adverse effect on the health, safety, and welfare of the citizens of the City. Visual blight conditions include, but are not limited to, any of the following conditions: The presence of excessive junk, refuse and garbage which is visible from a public street or sidewalk or from an adjoining property.

17.40.230 Refuse storage/disposal.

Every parcel with a multifamily, commercial or industrial structure shall have a trash receptacle on the premises. The trash receptacle shall be of sufficient size to accommodate the trash generated. The receptacle shall be screened from public view on at least 3 sides by a solid wall 6 feet in height and on the fourth side by a solid gate not less than 5 feet in height, in compliance with adopted Public Works Department Standards. The gate shall be maintained in good working order and shall remain closed except when in use. The wall and gate shall be architecturally compatible with the surrounding structures. Trash receptacles for single-family homes should be stored within the enclosed garage or behind a fence. (Prior code § 159.20.030(20))

8.04.190.B Commercial and industrial containers— Identification and maintenance.

Every commercial or industrial waste collector who owns, rents or controls any container, bin or other equipment used for the storage of garbage, industrial waste, market refuse or rubbish shall at all times keep in good repair and maintain in a clean and sanitary condition such container, bin or other equipment to the satisfaction of the County Health Officer. (Ord. 546, 5-6-14; prior code § 50.42)

4.16.010.A.5-Public Nuisance- Fire Hazard

It is unlawful and it shall be a public nuisance for any person owning, leasing, occupying or having charge or possession of any residential premises or residential property in the City to permit on such premises or property any operable vehicle, recreational vehicle, motor home, trailer, camper, camper shell and boat to be parked or stored outside of a garage or carport on an unpaved surface. "Paved" means covered by concrete, asphalt, brick, pavers, or a similar material as approved by the Director.

Corrective Action

Remove and properly dispose of all loose litter and trash from the exterior areas of the property and around the trash enclosure. Keep all exterior areas free of accumulation of trash, litter, and debris.

Remove wooden pallet from landscaped area. Keep all exterior areas clean and maintained.

Properly clean stains from the immediate area of the trash container enclosure.

Keep all trash containers/bins inside the trash enclosure to screen from public view. Gates on the enclosure shall remain closed when not in use.

Clean and sanitize the trash enclosure area and maintain. The business racks stored in trash enclosure area are not proper trash containers and should not be used as such. Contact Waste removal company (DVD) for additional dumpsters if needed.

Remove and properly dispose of all dry or dead plant matter, landscape debris, landscape trimmings, combustible refuse and waste or any other matter which by reason of its size, manner of growth and location, constitutes a fire hazard.
