ADMINISTRATIVE CITATION: Desert Hot Springs Municipal Code 4.24.010 provides for the issuance of an administrative citation for Desert Hot Springs Ordinance Violations. The administrative citation permits city personnel to provide administratively with its code enforcement efforts in an expedient, efficient, and fair manner for purposes of effectively protecting the health and safety of the general public and enhancing the quality of life for the citizens of the city.

TO APPEAL THIS CITATION: Within 21 days of the date of this citation, we must receive a written request for appeal at: City of Desert Hot Springs, Code Enforcement Dept., Citation Processing Center, PO Box 7275, Newport Beach, CA 92568-7275. The request for appeal must include (A) Name(s) of each appellant, (B) the citation number, (C) a specific statement of reasons for the appeal along with documents supporting the statement(s), (if any), (D) a check or money order as a deposit for the total penalty amount as shown on the citation, and (E) the signatures of all parties named as appellants and their mailing addresses. Any appeal filed that fails to provide all of the above listed information shall be deemed incomplete, and the right to appeal shall be forfeited. If the appeal is successful, the full penalty amount placed on deposit shall be refunded.

HARDSHIP/WELFARE WAIVER: In the event that you cannot pay the total penalty deposit as required, you may apply fo a HARDSHIP/WELFARE WAIVER. You must still appeal within the 21 days of the date of the citation. You must further provide a written statement specifically addressing why you should be granted a Hardship/Welfare Waiver (for Administrative Review). If APPROVED, your appeal will move forward. If DENIED, you will be notified and you must pay the total penalty amount immediately or you may lose your ability to appeal. DO NOT ATTEMPT TO EXPLOIT OR ABUSE THIS WAIVER, AS YOU MAY LOSE/FORFEIT YOUR APPEAL.

HOW TO PAY THE PENALTY AMOUNT: The penalty amount is indicated on the front side of this citation. Prior to receiving an invoice from the Revenue Collector, you may pay by mail. Payment should be made by personal check, cashier's check, or money order payable to the CITY OF DESERT HOT SPRINGS. Please write the citation number on your check or money order. DO NOT SEND CASH.

Another citation may be issued for the same violation(s), if the violation(s) are not corrected, for the same or an increased penalty amount. A criminal citation or an administrative abatement action may also be taken against you.
