An inspection of your property has revealed the following violation(s) of the Desert Hot Springs Municipal Code section (§):

Section

4.16.010.A.5-Public Nuisance- Fire Hazard

Fire Hazard. It is unlawful and it shall be a public nuisance for any person owning, leasing, occupying or having charge or possession of any premises or property in the City to maintain such premises or property in such a manner that has resulted in the accumulation of dry or dead plant matter, combustible refuse and waste or any other matter which by reason of its size, manner of growth and location, constitutes a fire hazard to any building, improvement, crop or other property.

4.16.010.A.3-Public Nuisance-Weeds

It is unlawful and it shall be a public nuisance for any person owning, leasing, occupying or having charge or possession of any premises or property in the City to maintain such premises or property in a manner that has resulted in overgrown weeds to be present on any front and visible side yards and sidewalks.

4.16.010.A.42.b-Public Nuisance- State Housing Law Cost Recovery

The City may declare by resolution pursuant to California Government Code Section 39561 et seq., that a public nuisance exists with respect to a specific parcel whenever that parcel is being maintained in a manner that has resulted in weeds, as that term is defined in California Government Code Section 39561.5, being grown upon the streets, sidewalks or private property in the City.

4.16.010.A.19.e-Public Nuisance- Visual Blight-
Junk/refuse/garbage visible

It is unlawful and it shall be declared a public nuisance for any person owning, leasing, occupying or having charge or possession of any premises or property in the City to maintain any such premises or property or improvement thereon in such a manner as to cause or to allow the premises, property or improvement to become defective, unsightly, or in such other condition of deterioration or disrepair as the same may cause substantial depreciation of the property values or similar detriment to surrounding properties, as well as an adverse effect on the health, safety, and welfare of the citizens of the City. Visual blight conditions include, but are not limited to, any of the following conditions: The presence of excessive junk, refuse and garbage which is visible from a public street or sidewalk or from an adjoining property.

Corrective Actions Required:

4.16.010.A.5-Public Nuisance- Fire Hazard

Cut away and remove all dead/dying vegetation, landscape trimmings, and all other combustible material on the vacant parcel.

4.16.010.A.3-Public Nuisance-Weeds

Cut away and remove all weed growth on the property.

4.16.010.A.42.b-Public Nuisance- State Housing Law Cost Recovery

Cut away and remove all weed growth on the property.


4.16.010.A.19.e-Public Nuisance- Visual Blight- Junk/refuse/garbage visible

Remove and properly dispose of all junk, trash, discarded items, and debris being stored on this property.
