It is unlawful and a misdemeanor for any person to abandon, park, store, or leave or permit the abandonment, parking, storing or leaving of any licensed or unlicensed vehicle, or parts thereof, which is in an abandoned, wrecked, dismantled or inoperative condition upon any private property or public property within the City for a period in excess of 10 days, unless 10.52.030-Abandoned, Wrecked, Dismantled or Inoperative Vehicles-Act such vehicle, or parts thereof, is completely enclosed within a building in a lawful manner where it is not plainly visible from the street or other public or private property, or unless such vehicle is stored or parked in a lawful manner on private property in connection with the business of a licensed dismantler, a licensed vehicle dealer, or a licensed junk dealer. 
Repair, remove or store the inoperable Chevy inside a garage. Park all vehicles in the driveway or on the street, do not park in the front or side yard.


