#### Section

It is unlawful and it shall be declared a public nuisance for any person owning, leasing, occupying or having charge or possession of any premises or property in the City to maintain upon any such premises or property any building or structure, or any part thereof, which has been constructed or is maintained in violation of any applicable state or local law or regulation relating to the condition, use or maintenance of such building or structure.

b. In Industrial (I-L, I-M, I-E) districts, but only when the fencing is located only on the side and/or rear property lines and is not visible from public right-of-way. The exception to the chain link fence requirements in the industrial districts is:

i. Vacant property five (5) acres or greater in size, as needed to security the property from any nuisance, including vandalism or trespass, as determined by the Compliance Manager, or his/her designee. However, chain link shall not be along the frontage of the property. Split rail or post and wire fencing may be used along the frontage of the property.

c. All chain link fencing must have top rail, bottom wire and caps on the poles.

d. All chain link fencing must be properly maintained at all times, including being free from holes, tears, or bent or otherwise disfigured.
